2000 Trees Festival	4	<ul style="list-style-type: none"> Capacity – Currently the site is limited to 14,999 people at any one time. The Organisers will sell 12,500 tickets this year with no plans to increase this due to physical constraints of the site. Were any increase in numbers be sought, this would be confined to day ticket holders only Exit Procedure – The Organisers are conscious of delays for both Festivalgoers and Residents heading towards Andoversford. Phased traffic lights will now be installed at the Withington junction with A436, the management of which will be judged according to the traffic at the junction Mud on the Road – This is dealt with on an ad hoc basis determined by John Platt, the Landowner Noise – A specialist study by professional sound engineers has been undertaken in the past considering the nearest sound sensitive residences although wind and atmospheric conditions can affect this. The Organisers will monitor sound from the silent disco at the nearest sound sensitive residences this year Tickets – The village is grateful for the free tickets that are offered to Residents Variation Application – The Organisers confirmed that the intention is to align the playing of music and bars opening and closing times. As there is no foreseeable increase in the number of Festivalgoers, they believe that there is no need to meet with the Parish Council in future. The Parish Council confirmed their wish to meet with the Organisers in future to deal with matters that arise Village Community Initiatives – The space provided by the Organisers is appreciated as it supports village projects 	<ul style="list-style-type: none"> Clerk – Respond to CDC to retain licensing condition regarding meeting the Parish Council annually



Some use of the new layout will occur in autumn 2026 A436 – Following a campaign by the Parish Council, average speed cameras have been installed between Seven Springs and Shipton Oliffe Burglaries, fly tipping and violence against farmers who approach hare coursers appear to be on the rise in rural areas Unitary Council – Three options (Gloucestershire wide, East/West split and Gloucester/the rest of Gloucestershire split) are being discussed over which public input will be sought shortly. HM Government will decide which model will be pursued in spring 2026 with installation of the new model in 2027 or 2028. 	•
