<b>Update from County Councillor</b>	13	<ul style="list-style-type: none"> <li>Local government reorganisation: still on track for all existing councils to be abolished in May 2028. County Council will vote in November on the two options being explored (Gloucestershire wide or East/West Gloucestershire). The Government will then make its decision and will communicate that in summer next year. There will be a Government led consultation on that proposal</li> <li>Withington Primary School: Many local primary schools are struggling with numbers and the 'pipeline' shrinking. It's a sad situation but one which looks very challenging given the nearby Andoversford and Chedworth schools also catering for the same group of children</li> <li>A417 Missing Link - 500 people are working on site and some of the new road will start taking traffic next Spring.
